Brian Chewcaskie, Esq. stated: I am here on behalf of the Borough of Fort Lee. We are here for a subdivision and seeking courtesy review of the submitted plans. About three or four years ago there was a subdivision deed filed but the subdivision never came here for your review so we feel that it was done inappropriately and therefore invalid. We need Board review and adjustment of the subdivision to accommodate the new building. The Borough has been in partnership with the County for a few years now and they have finally decided what they wanted to do. This will be one hundred percent senior housing. The Borough will contribute the land and a certain cash portion. We are here for completeness on the subdivision. We will request the waivers that have been pointed out by the Board Planner and the items that were requested are being prepared.

Ms. Ketive questioned: What is the zoning of this property, and will it need to be changed?

Mr. Chewcaskie stated: I am not sure, but I believe it is commercial. Technically, due to the review and it being a government request, the zoning does not need to be changed.

Mr. Karp stated: It is C-1 according to the subdivision plan.

Vice Chairwoman Cooney questioned: So, you do not need to change the zoning?

Mr. Chewcaskie stated: No, because of it being a courtesy review and since it is a government entity we just need the Board to review it and make sure it complies. We are seeking the subdivision and a courtesy review and will provide the Housing Authority with whatever comments the Board may have.

Mr. Kaplan questioned: This housing helps with the Borough's affordable housing obligation?

Mr. Chewcaskie stated: Yes.

A motion was made by Mr. Pohan, seconded by Mr. Sargenti, and passed on a vote of 8 to 0 by members Pohan, Marshall, Ferris, Suh, Sargenti, Ketive, Kaplan and Cooney, to deem the application complete upon submittal of the outstanding items. Councilman Yoon abstained from the vote.
